WHAT IS BEING PLANNED

The project proposes to widen the Pudding Creek Bridge on State Route (SR) 1 at post mile 62.12 in Mendocino County. The proposed project would widen the bridge on both sides to accommodate two 12-foot wide lanes, two 8-foot wide shoulders, and two 6-foot wide separated pedestrian proposes "Complete Streets" improvements by constructing sidewalks on both sides of SR 1 from Pudding Creek Bridge south to Elm Street and north to Pudding Creek Drive and drainage improvements and relocation of the City of Fort

walkways and upgrade the bridge rails. The project also Bragg's waterline from the Pudding Creek Dam to SR 1.
