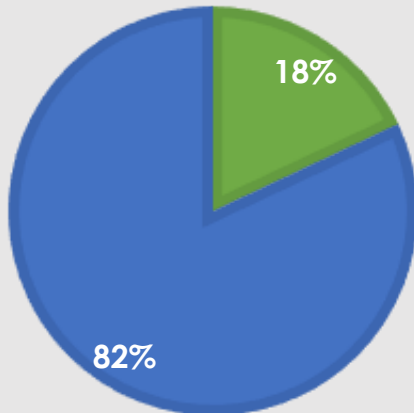

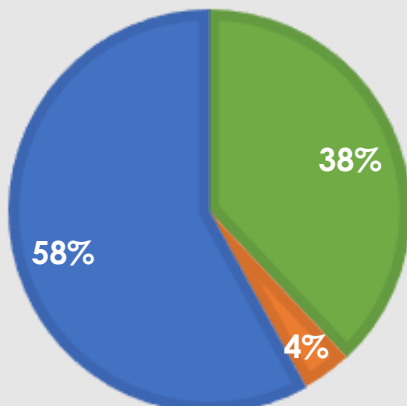

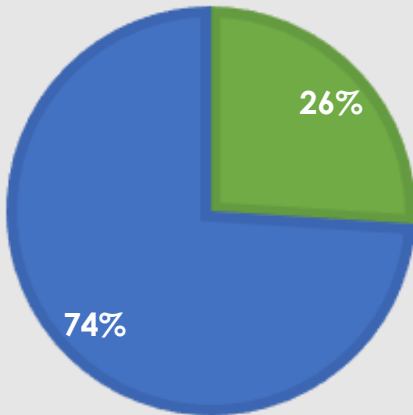

District 6 DBE, SB, and DVBE Participation at a glance:

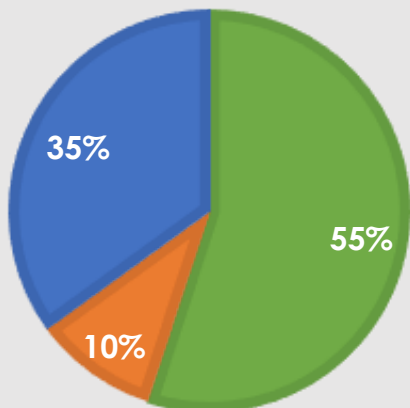
FEDERAL MAJOR CONSTRUCTION CONTRACTS

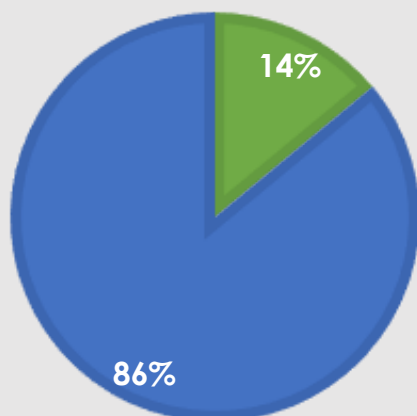

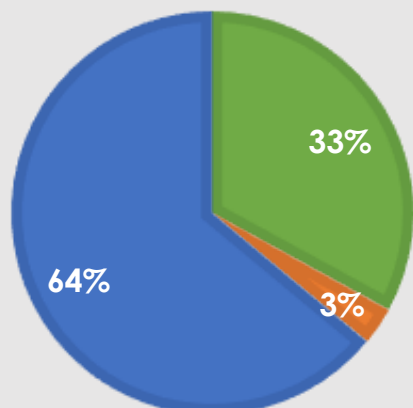

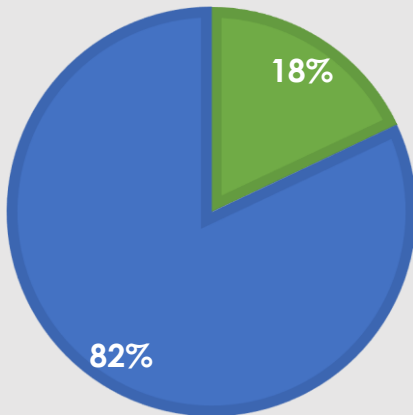

District 8 DBE, SB, and DVBE Participation at a glance:

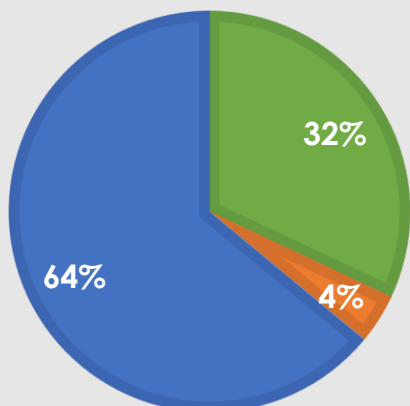
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$54,356,490

OUTREACH

District 8 is currently hosting multiple Virtual Mandatory Pre-Bid (VMPB) Meetings. At these meetings, we have guest speaker presentation(s) from the Small Business Development Center and Procurement Technical Assistance Center for certification and contract supportive services. The VMPB meetings include a networking session for prime contractors and subcontractors to make a presentation about their business needs/contracting services in relation to the project.

- On 12/3/20, District 8 successfully hosted a VMPB for project 08-1F7304, which had 32 attendees representing 23 companies. The projects' capital estimation is \$20 million with DBE goal of 15%, and the bid opened on 1/12/21.

The next scheduled D8 VMPB meetings and pending VMPB Projects are listed in the look ahead table above. Some details for the upcoming VMPBs are listed as follows:

- January 19, 2021 - Network Pitch Practice Session for VMPB and System Test Meeting.
- January 21, 2021 - Project 08-1C0824, advertised 12/10/20 and capital estimation of \$290 million.
- A VMPB meeting for project 08- 0E33U4 is being scheduled. The projects' estimated advertisement date is 2/8/21 with VMPB in February and capital estimation is \$34 million.
