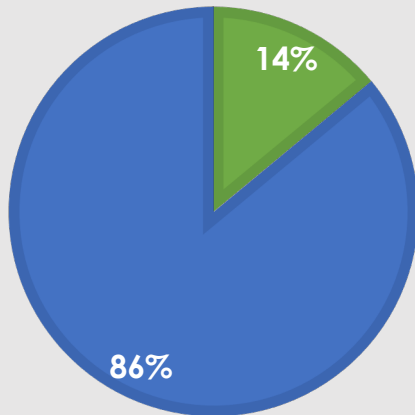

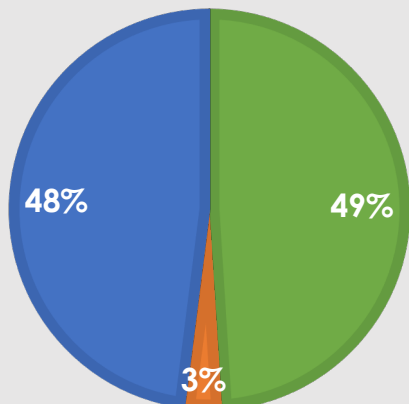

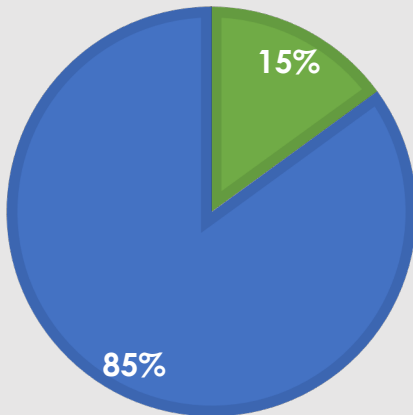

District 6 DBE, SB, and DVBE Participation at a glance:

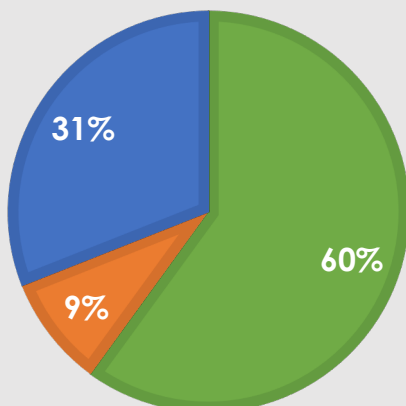

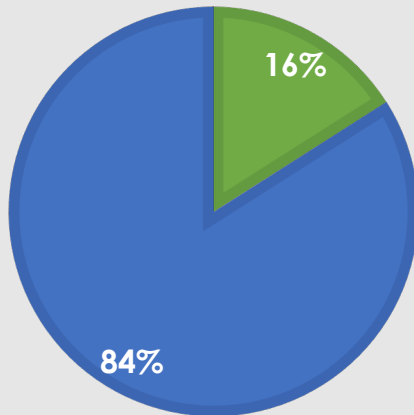

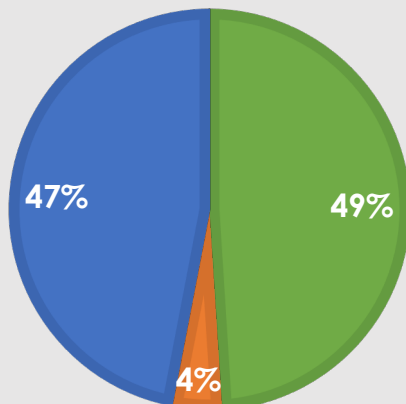

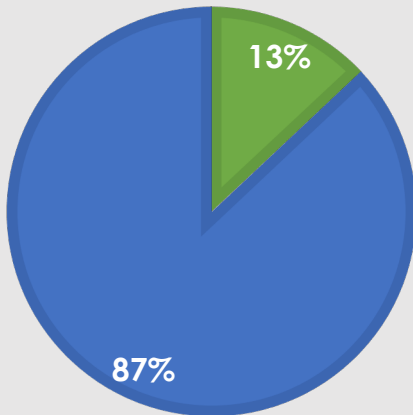

## District 8 DBE, SB, and DVBE Participation at a glance:

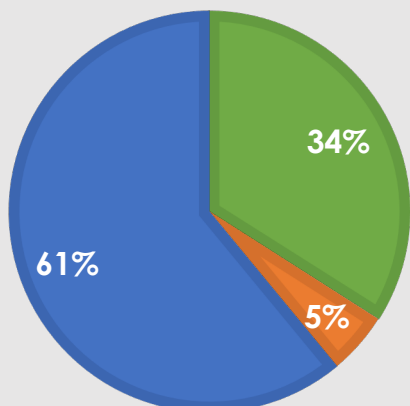
### FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$414,362,267
