

FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$58,340,090





 - Sessions had 26 & 34 participating small businesses respectively, with 71% of attendees who responded to post-event polling stating they felt better prepared to bid on future Caltrans projects. 100% of attendees who responded to post-event polling also stated that they had a better understanding about the needs of Prime-Sub partnerships, and 95% indicated they would recommend this outreach event to colleagues or industry partners.







FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$48,283,686







FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$123,635,702




