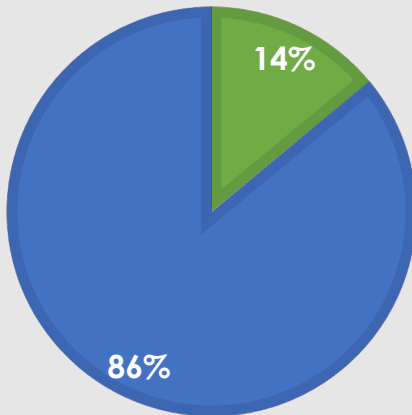

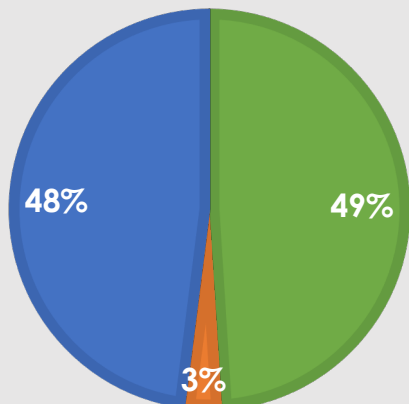
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$42,114,959

DISTRICT 5 DIRECTOR'S UPDATE

Scenic Highway 1 reopened ahead of schedule on April 23, 2021, just months after torrential rain damaged several major sections of the highway, including a complete loss of the roadway at Rat Creek. S. Chaves Construction, a certified Micro Business (MB and SB-PW), completed a \$4 million dollar contract for major repairs south of Rat Creek, and another local contractor, Papich Construction, was awarded an \$11.2 million contract to repair Rat Creek and other damaged areas north of that location. Amazingly, all work for these two contracts was completed in just 85 working days.

On Wednesday, May 5, Caltrans District 5 awarded a \$150,000 contract to Taylor Jane Construction, a certified Micro Business (MB), to fix a sinkhole on Highway 150 in Santa Barbara County.

On Friday, May 7, we awarded a \$750,000 contract to Access Limited Construction, a certified Small Business (SB-PW) for the Coastlands Wall II stabilization on Highway 1 in

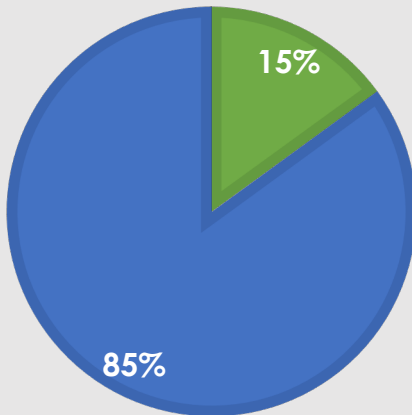

District 6 DBE, SB, and DVBE Participation at a glance:

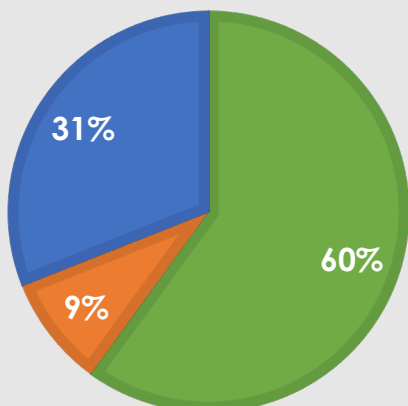
FEDERAL MAJOR CONSTRUCTION CONTRACTS

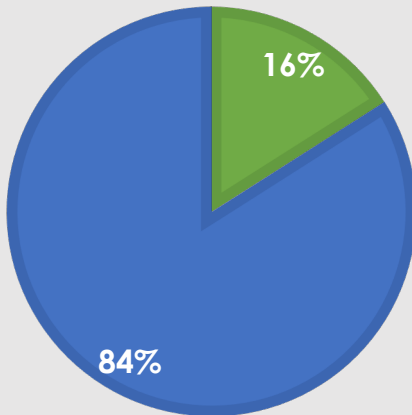

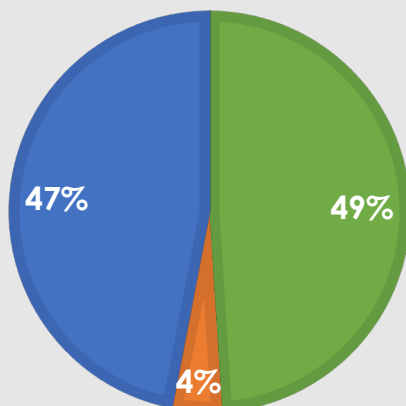
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$119,946,822

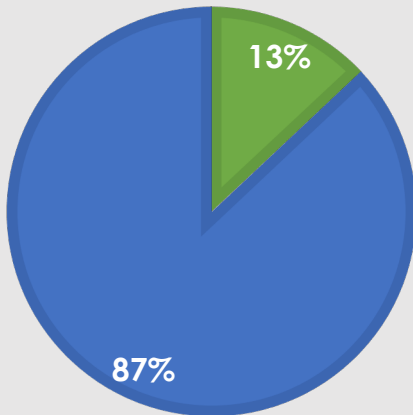

District 8 DBE, SB, and DVBE Participation at a glance:

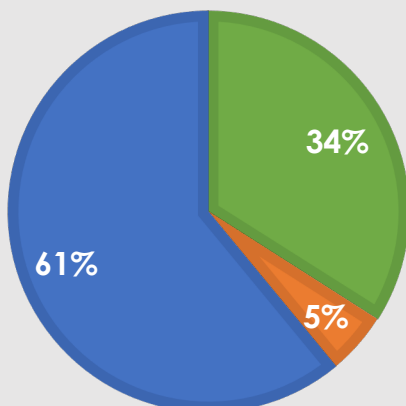
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$390,147,013

CALMENTOR (Small Business A&E mentoring program – Districts 7, 8 and 12)

- On April 29, 2021, District 8 helped to host a virtual Calmentor Spring Event for the Southern California Alliance Calmentor Program for Districts D7, D8, and D12. The event included representatives from Caltrans' partners, such as High-Speed Rail, Los Angeles County, LA Metro, Orange County Transportation Authority, and San Bernardino County Transportation Authority. Nearly 150 people attended. A follow-up email containing a link to the meeting video, text, and attendance list was sent to all who registered for the event, as an additional outreach effort.
