





District 6 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$85,046,111



District 7 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$237,752,542



District 8 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS
