





District 10 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$91,848,489



District 11 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$89,052,676



District 12 DBE, SB, and DVBE Participation at a glance:


FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$118,100,730
