DBE Program Overview

DBE Eligibility:

- The business must be at least 51% owned by a socially and economically disadvantaged individual(s): Presumptive
 groups include Asian-Pacific, Black, Hispanic, Native American, Subcontinent Asian, Women, or any individual found to
 be socially and economically disadvantaged on a case-by-case basis
- The business's last 3-year average gross receipts cannot exceed \$30.72 million (varies by industry)
- Personal net worth of the disadvantaged owner(s) cannot exceed \$2.047 million
- Owner(s) duties must include managerial and operational control of the business
- Must be independently owned and operated

Recent Update:

The Final Rule, effective May 9th, 2024

- The Final Rule is the most significant overhaul to the DBE Program in a decade
- Increased personal net worth (PNW) limits
- Revises the process for interstate certification and makes it easier
- Provides answers to common technical questions

Calmentor Program

Overview

- Caltrans Regional/District Consultant Services Unit (CSU) has implemented an Architectural & Engineering (A&E) mentor-protégé program, also known as "Calmentor"
- Partnering with the American Council of Engineering Companies (ACEC), the Calmentor Program promotes partnership with the private consulting industry
- The Calmentor Program is consistent with the Governor's Executive Order No. S-11-06 to encourage new businesses, grow existing businesses, and promote small and emerging business contracting with the State of California,
- Calmentor supports the participation of certified Small Business Enterprise (SBE), Disadvantaged Business Enterprise (DBE), and Disabled Veterans Business Enterprise (DVBE) firms in the Central Region.
- Voluntary participation in the program is through acceptance and screening of completed applications from mentors and proteges.

The Mission of the Calmentor Program is to increase the pool of small firms participating in transportation projects by providing them opportunities to network and partner with larger, established firms.

Consultant Task Order Manager

- Substantial knowledge and experience working in the environmental planning field, including in-depth knowledge of NEPA & CEQA
- "Substantial knowledge" is defined as having a Degree (Bachelors, Masters, or higher) in environmental planning or a related field.
- "Substantial experience" is defined as having a documented minimum five (5) years of demonstrated experience having worked in a relevant field for sufficient time to ensure ability to control and advise on the full range of activities and to be expert in terms of a wide variety of special, unusual or complex features of the work in performing NEPA & CEQA technical support services.

Environmental Generalist Personnel Requirements

The Consultant's personnel shall be capable, competent, and experienced in performing the types of work in this Contract with minimal instruction. Personnel skill level should match the specific job classifications and task complexity. The Consultant's personnel shall be knowledgeable about, and comply with, all applicable Federal, State, and Local laws and regulations.

Environmental Generalist

- Bachelor Degree in Environmental, Urban Regional Planning or related field and
- Shall have a documented minimum three (3) years of demonstrated experience acceptable to Caltrans, equivalent to a Caltrans Associate Environmental Planner.

Biology

- Bachelor Degree in Natural Sciences field and
- Shall have a documented minimum three (3) years of demonstrated experience acceptable to Caltrans in: (1) biological impact analysis of transportation projects including impacts to species of concern and their habitats, wetlands, or waters of the United State (U.S.); or (2) biological development and monitoring

Environmental Generalist Personnel Requirements cont.

Air Quality

 The Consultant's personnel who conduct Air Quality Studies shall be knowledgeable and capable of performing Air Quality Studies, including use of common analysis models and methods such as the EMFAC 2017 and CALINE4 models (or most recent models approved), Caltrans' and FHWA's CO Protocol and PM10 and PM 2.5, Qualitative Analysis and Quantitative Guidance, and the Local CEQA analysis guidelines.

Noise and Vibration

• Expertise in acoustic and vibration modeling field investigations to transportation noise is required. Some staff development work and research may be required with this Contract. A documented minimum five (5) years of demonstrated experience acceptable to Caltrans analyzing complex transportation noise and vibration is required.

Water Quality

 A Degree (Bachelors, Masters, or higher) in Water Quality, Hydrology, or related Environmental Engineering field from an ABET accredited institution (College or University) or possession of a valid Engineer-in-Training (EIT) certificate issued or accepted by the California State Board for Professional Engineers, Land Surveyors, and Geologists.

Environmental Generalist Paleontological

Paleontological

- The Consultant shall provide a professional Geologist licensed in the State of California in good standing with the California State Board for Professional Engineers, Land Surveyors, and Geologists at all times during the Contract period for Paleontology work conducted under the contract.
- The license Geologist must also be a qualified Paleontologist with a
 paleontological resource Excavation Permit for the collection of vertebrate
 fossils issued by the Bureau of Land Management.
- If a licensed professional Geologist is not available as stated above, the Consultant must provide, in addition to a professional licensed Geologist, a qualified Paleontologist with a paleontological resource excavation permit for the collection of the vertebrate fossils issued by the Bureau of Land Management.
- The professional Paleontologist shall work under the direction of the professional Geologist licensed in the State of California in good standing with the California State Board for Professional Engineers, Land Surveyors, and Geologists at all times during the Contract period.

- A Degree (Bachelors, Masters, or higher) in Landscape Architecture from on LAAB accredited institution (College or University).
- Registered Landscape Architect licensed in the State of California in good standing with the California Architects Board Landscape Architects Technical Committee at all times during the Contract period.
